\* Effective for all hours worked after June 1, 2018 a **vacation fund** has been approved by members of Local 11, Area 37. This is an “after tax” deduction. Contractors are to deduct \$6.64 an hour for **straight time** hours; \$9.96 for hours worked at **time and one half**; and \$13.28 per hour for **double-time** hours, which are to be submitted to our administrator along with the above listed fringe benefits.
