** Effective for all hours worked after June 1, 2018 a **vacation fund** has been approved by members of Local 11, Area 362. This is an "after tax" deduction from members payroll check. Contractors are to **deduct** \$8.00 an hour for *straight time* hours (\$12.00 for hours worked at *time and one half*, and \$16.00 per hour for *double-time* hours) to be submitted to our administrator along with the normal pension and welfare benefits.
