*** Effective for all hours worked after June 1, 2017 a **vacation fund** has been approved by members of Local 11, Area 362. This is an “after tax” deduction from members payroll check. Contractors are to **deduct** \$4.73 an hour for **straight time** hours (\$7.10 for hours worked at **time and one half**, and \$9.46 per hour for **double-time** hours) to be submitted to our administrator along with the normal pension and welfare benefits.

APPRENTICE BASE WAGE RATES & BENEFITS:

1st Year Apprentice = 70% Journeyman Wage (\$31.40) + Journeyman Benefits; *No Sav/Vac* Local Dues \$1.90; Int'l Dues \$0.63
2nd Year Apprentice = 80% Journeyman Wage (\$35.88) + Journeyman Benefits; *No Sav/Vac* Local Dues \$2.03; Int'l Dues \$0.68
3rd Year Apprentice = 90% Journeyman Wage (\$40.37) + Journeyman Benefits; + Sav/Vac Local Dues \$2.17; Int'l Dues \$0.72
