** Effective for all hours worked after June 1, 2021 a **vacation fund** has been approved by members of Local 11 Area 362. This is an “after tax” deduction from members payroll check. Contractors are to **deduct** \$5.70 an hour for **straight time** hours (\$8.55 for hours worked at **time and one half**, and \$11.40 per hour for **double-time** hours) to be submitted to our administrator along with the normal pension and welfare benefits.

APPRENTICE BASE WAGE RATES & BENEFITS:

1st Year Apprentice = 70% Journeyman Wage (\$35.78) + Journeyman Benefits; *No Sav/Vac* LD \$2.38; ID \$0.79; BF \$ 0.21
2nd Year Apprentice = 80% Journeyman Wage (\$40.89) + Journeyman Benefits; *No Sav/Vac* LD \$2.53; ID \$0.84;BF \$0.24
3rd Year Apprentice = 90% Journeyman Wage (\$46.00) + Journeyman Benefits; + *Sav/Vac* LD \$2.69; ID \$0.90; BF \$0.27
